## Minutes for 6/27/2022

### Roll Call and Sign in-

- Both of the absent parents notified Mrs. Sadler of their absence ahead of time and were given the agenda in Google Docs form. Their comments and input for each aspect of the ESSER III plan were visible to those present.

### Review of ESSER III Plans

- Use of Funds plan reviewed, all stakeholders were shown dollar amounts, explained how the money will be allocated, stakeholders agreed upon the use and expressed their appreciation that federal funds are there to help close some gaps
- Stakeholders first identified our current strengths, areas of concern, and barriers that might be present if campus were to close again due to the pandemic.
  - Strengths were identified as our amazing staff, technology upgrades, and continued proof of a solid academic foundation. STAAR scores and other academic data were provided by Mrs. Sadler in order to show stakeholders the gaps being addressed and closed.
  - Areas of Concern are those of the same as two years ago, lack of parent involvement and lack of connectivity in rural areas. (if having to go remote again, even hotspots and wifi are weak in some areas of our large district)
  - Barriers are the same, a fundamental lack of parent involvement plus a lack of time and manpower if school were to close again. The first closure took a toll on teachers, staff and the kids' families.
- Academic needs were addressed- Discussed the platform MyPath that was purchased last year and the dissatisfaction from teachers and parents. A new platform will be purchased that is better at tracking progress and providing helpful data and analysis. Teachers will research this, choose the platform and purchase can occur Sept. 1
- SEL needs were addressed- Mrs. Sadler found a program called "Esteem" and samples of lessons were provided to the stakeholders. All present liked the program and agreed it will be beneficial to our kids, as it addressed the major areas of social, emotional and mental health needs that kids are facing these days.

- Staff SEL needs were addressed- Ideas were given, such as fun field trips for teachers on inservice days, easy access to mentors and counselors is needed, duty free time increased, and an area to relax or go grab a snack.
- Parent Involvement was definitely the highest need discussed when reviewing the RIPICS. Parents in the stakeholders meeting vocalized that what most parents probably need are school supplies at home and some ideas to create a learning and productive environment at home. Mrs. Sadler said she would address those needs in a “series” type of family engagement programs. Stakeholders were asked to continue thinking of ideas and to volunteer to help Mrs. Sadler host the events.
